Calling all parents of children at Court Lane Infants and Juniors Academies! We have a vacancy for a Parent Governor to join the existing Governing Body team.

What is the Governing Body?

Together with University of Chichester Academy Trust and the Head Teachers, the Local Governing Body has overall responsibility for the running of the school; amongst many duties Governors are involved in deciding school policies, allocating the school's budget and appointing senior staff.

The Governing Body has 3 core functions:

- Ensuring clarity of vision, ethos and strategic direction;
- Holding executive leaders to account for the educational performance of the organisation and its pupils, and the performance management of staff; and
- Overseeing the financial performance of the organisation and making sure its money is well spent.

What do I need to be a governor?

No special qualifications are needed, the most important thing is to have a keen interest in the school and be prepared to play an active part in the Governing Body's work. To support Governors in their work full training is provided at no cost to the individual. In our school we have two Parent Governors who serve for a term of office of 4 years, and we currently have a vacancy. At this moment in time, we are ideally looking for any parent with a child in either Court Lane Juniors or Infants Academies.

What is involved?

Governors at Court Lane Academies meet every half term and together with the Head Teachers set the aims and objectives of the school in line with national guidelines. They monitor and evaluate progress the school is making and act as a source of challenge and support to the Head Teachers.

What are we looking for?

We are actively looking to increase the diversity of our governing body, so we would particularly welcome applicants from members of underrepresented groups, but we equally welcome interest from anyone who is interested in helping the school be the best it can be. Full and free training is available, and governors are encouraged to attend regular training sessions, either in person, or online.

How often does the Governing body meet?

The full Governing Body normally meets every half term, usually at 1630-1830 on a Monday.

You must be over 18 to apply and all governors must have Disclosure and Barring Service (DBS) check which will be provided by the school.
